CRIME / SUSPICIOUS ACTIVITY IN PROGRESS

Sacramento Police Emergency (from cell phone) at (916) 732-0100. Outside City limits, from a landline, or if a caller's location is unknown 9-1-1.

SUSPICIOUS ACTIVITY/TIPS

Immediately call Sacramento Police non-emergency at (916) 808-5471 x3. Caller must be willing to stand by and/or give detailed information. Also alert details to the Alliance at info@powerinn.org.

STREET RACING

Note license plate, description and direction traveling. Call police non-emergency at (916) 808-5471. If a photo is available, email information to the Alliance at info@powerinn.org

BURGLARY (BREAK IN)

Report all burglaries to Sacramento Police non-emergency immediately at (916) 808-5471. Also report details to the Alliance at (916) 453-8888 info@powerinn.org.

Recommendations:

- Invest in quality lighting and surveillance cameras with remote viewing capability.
- Place cameras inside and outside facility.
- Secure all tools in a locked structure out of view.
- Block roll-up doors with vehicles or heavy equipment.

CAMPING/TRESPASSING

Subject and reporting person must be present for Police to respond. Property / business owner or representative must sign a Notice of Trespass.

Witnesses and property / business owner should contact SPD directly at (916) 808-5471.

Private Property

Owners may discard items immediately. As a safeguard, post a 2-24 hours removal notice and remove debris after time limit. Notices are available from the Alliance.

Public Property

Alliance crew posts a 24-hour removal notice, and will remove items the next business day.

Railroad Property

These are maintained by rail companies. Contact Power Inn Alliance to report exact location.

Recommendations:

- Inspect property minimum once a week.
- Cut tall brush and trees 6' from ground and trim brush to 2' height to prevent hidden campsites.
- Remove access to water and electricity.
- Install bright lights and quality surveillance, with motion detection and remote viewing.
- Lock and enclose all dumpsters.
- Turn off Wi-Fi after hours.

ILLEGAL DUMPING

The Alliance crew services public spaces that benefit the general business district.

Private Property

Property or business owners should remove dumped items quickly to prevent further dumping. Contact the Alliance for hauler referrals.

Tires

More than 9 tires need to be hauled by a permitted professional. Contact the Alliance for referrals.

Dumping in Progress

If safely possible, get photo evidence and license plate. Reporter must be willing to be a witness. Immediately call 3-1-1 with details. Email any photos to 3-1-1 and the Alliance.

Recommendations:

- Install bright lights and quality surveillance inside and outside.
- Block entrances to driveways.
- Block doors with heavy equipment.
- Remove keys and lock vehicles.

GRAFFITI

File a Police report (vandalism) and include ALL costs for removal (including gas) so Police can prosecute taggers.

The Alliance crew cannot remove graffiti on private property. Property / business owners should take a photo, then remove or cover paint within 72 hours to remove the notoriety.

Recommendations:

- Cover the walls with live or artificial greenery or art.
- Install bright lights and surveillance.
- Remove tagging immediately.
